Veteran's Day, November 11, inspired us in many ways this year. First, we honored our veterans, to whom the day is dedicated. At the LEL Section meeting, Chair **Don Slesnick**, himself a veteran, asked veterans to stand and be recognized by the Section. The moment reminded us all how much we owe to those who stood, and to those who are no longer with us.



The College itself had two unforgettable events. First, thanks to Past President Bill Killberg, on Saturday afternoon 400 Fellows and their guests listened to a conversation between Bill and Justice Ruth Bader Ginsburg: "the legal architect of the modern women's movement." Justice Ginsburg talked with Bill about the cases she chose and the strategies she employed to promote "equal citizenship stature for men and women." It was a rare opportunity to listen to Justice Ginsburg



discuss why she took certain cases, how she and her colleagues worked to find those cases, and how she tried to move the Court incrementally toward "equal citizenship."

Justice Ginsburg also joined us at our Induction Dinner, where I was honored to present her with an Award from the College in recognition of, and appreciation for, her contributions to the field of labor and employment law. It was the first time a sitting Supreme Court Justice attended our induction dinner. After her brief remarks, we joined with the late Justice Scalia, who wished her "a hundred years" – and gave her a thunderous standing ovation.

The induction dinner gave me an opportunity to reflect on where the College has been, where it is today, and where it is going. I joined the College in 1998, when I knew a large percentage of Fellows. Many were – to me – paragons of collegial practice. I had seen some in arbitration or mediation, vigorously representing clients and courteously working with their opponents. I had been on committees with others and admired the way they worked toward our common goals. I was proud to be part of a well-balanced group of the top practitioners of labor and employment law.

Twenty years later, I am still proud to be a Fellow and honored to serve the College. But I worry about our future. In the last five years, between 54% and 73% of our new Fellows have been from Management. I do not doubt their qualifications – they were vetted by our rigorous Circuit Credential Committees. Nevertheless, I am concerned about the potential consequences of the growing imbalance between constituencies.

We humans are tribal (and as lawyers we qualify as humans). Group members attribute good qualities to themselves and less good qualities to the "other." Collegiality is a process of overcoming the tribal impulse with a rational response. We must recognize the other person as not only a member of a different constituency, but also a member of a larger tribe we both belong to – the College.

We have, as a group, chosen each Fellow to be a member of our larger tribe. Collegiality and respect, regardless of constituency is what we owe each of them – from new inductees to our founding members.

To mitigate the growing imbalance in our inductees, the Strategic Planning Committee is searching for ways to involve more of the top professionals from our less numerous constituencies in the College. We welcome your suggestions. As Treasurer **David Borgen** wrote in the last newsletter, it is up to all of us to nominate Fellows from constituencies other than our own.

Finally, when I think of collegiality I am reminded of one of my favorite old New Yorker magazine cartoons. In six panels, two lawyers go toe to toe in a courtroom, vigorously representing their clients. In the seventh panel they leave the courtroom, and in the eighth they have lunch together. That's collegiality.

#### February 16-17, 2018 - New Orleans, LA: Joint Regional Program

The Saturday morning program will feature outgoing NLRB Chair Phil Miscimarra sharing his thoughts on the time he spent as Chair and what's ahead for the Board.
