THE PRESIDENT'S PERSPECTIVE

The College turns 21 this year. We have reached the age of majority as recognized by almost all states in the nation...and that is a notable tribute to all the men and women who have helped carry out the vision of the founders who established the College's goal of bringing together the most accomplished labor and employment lawyers to foster professionalism, civility and excellence in our practice area. While congratulatory sentiment is a helpful encouragement for continued success, reaching this maturity milestone also brings with it a greater degree of responsibility for each of us to aid the College in continuing



to lead, educate, counsel and inspire young lawyers who have chosen the same career paths that led each of us to Fellowship.

While I am humbled by the task of leading the College, I am excited by the opportunity to help direct our collective attention to continuing to build on the foundation of excellence established by the hard work of the Fellows too numerous to honor here. Participation can be aided by each of us simply agreeing to coordinate regional educational programs or opting to help raise money to allow the Stephen E. Tallent Video History Project to produce new insightful looks into our past accomplishments as a profession. Inclusion is served by the necessary mentoring of worthy young lawyers so that they can be exposed to career paths that would lead them to Fellowship. As leaders of firms, agencies, law school programs and alternate dispute resolution forums, we are in the enviable position to promote practice excellence, scholarship and community involvement that are the elements necessary to election as Fellows. It's not that hard to do, so let's all just do it. And I guarantee that you will find participating in educational programs, College efforts and mentoring to be satisfying and fun!

With that bit of my usual organizational cheerleading having been completed, I invite all of you to go onto our newly designed website to enjoy the new features and informational resources, to get to know our newly selected officers and Board members and to recognize the accomplishments of the past year under the impressive leadership of Don Slesnick.
