# THE TREASURER'S TAKE



As I sat down to write this column, I first re-read the columns written on this topic by my fellow officers: John Runyan, David Borgen, and Alan Symonette. They are three of the greatest individuals with whom I've had the privilege of working. They have each described their particular reasons so eloquently and have provided many of the very same reasons why I too am grateful for being a Fellow of the College. So it is, quite frankly, a daunting task to explain my thoughts without repeating what they have already said.

My induction into the College in 2005 was one of the highlights of my 40-year legal career. Not because my colleagues thought that I had the technical skills, but because my peers in the community acknowledged that I demonstrated professionalism, civility, and integrity. I value my reputation for being fair and a straight shooter more than any other aspect of my professional credentials, and my admission into the College confirmed what was most important to me.

But let's face it. Sometimes it's quite the challenge to live up to the ideals of the College in the face of difficult opposing counsel or clients who expect you to be overly zealous. Frankly, for some of us, it would just be easier not to have to meet the College's exacting standards of civility. I entered the profession when there were nowhere near as many women practicing law as we are fortunate to have today. Back then, many of the female lawyers were taught, directly or indirectly, that to succeed, women had to be even more aggressive than their male counterparts. I drank that Kool-Aid, and it was a lesson that was difficult to unlearn. However, being a College Fellow is a constant reminder of the core principles to which we must adhere, and that the old rules for how female lawyers should conduct themselves simply do not work today. On balance, I believe I am a better advocate, adversary, and counselor because I have the privilege of being a Fellow.

Through the relationships I've formed in the College, I have gotten to know the best minds and hearts in our chosen field. I've crossed paths again with many whom I knew at the start of my career. In working on the President's Book, I interviewed my very first boss, **Harold Datz**, who then headed the NLRB's Division of Advice. I also interviewed John Higgins, who in the late 70's was someone whom I respected from afar. Lynne Deitch and I reconnected after 20 years, and she mentored me throughout my tenure in the College. Maurice Wexler showed me enormous kindness and mentorship even before we got to know one another well. Although this list goes on and on, my point is that the College affords us all the unique opportunity to befriend colleagues from across the U.S. and Canada, and it has been rewarding beyond measure.

Being a Fellow also presents us the opportunity to recognize and reward talent. Every year, I try to nominate those who exemplify our core values. It is a unique way for me to pay it forward, in recognition of those who were generous enough to support my nomination years ago. Serving on a circuit credentials committee is a wonderful way to carry on our mission and to form lasting bonds with our fellow committee members. Sometimes the task is difficult, but the vetting process teaches us what is truly valued in the practice of labor and employment law. Our circuit committee chairs and their committees perform extraordinary service to the College.

There are several other projects in which I have been involved which have been both challenging and personally rewarding. The Strategic Plan was the work of numerous Fellows who approached the task with creativity, commitment, and a wicked sense of humor. It was a privilege to co-chair this effort with Lisa Moss, who became my partner-incrime extraordinaire. Our Strategic Planning Committee devoted countless hours to setting the course for the future of the College. Ever since the Board approved the Strategic Plan, John Runyan and Board Regional Activities Committee Chair Homer Deakins have kept us on track to ensure that the Strategic Plan's goals and objectives become reality. As you have probably read countless times, the Strategic Plan's main focus is to ensure that the College stays true to its mission while increasing exponentially the opportunities for Fellow involvement.

Finally, none of this would ever happen without the tireless efforts and friendship of Susan Wan and Jen Motley. Their wisdom gets us through the most difficult situations, and I still cannot fathom how they keep track of all of us.

So even if it is a pain to be civil sometimes, I can't imagine what my career would have been like without the experience of belonging to the College and being involved in its activities and programming. If you haven't participated thus far, I urge you to do so. It can be an absolute blast. Looking forward to seeing you in November.

Published in the wake of the Weinstein allegations and the revival of #MeToo, the treatise collects new substantive and procedural developments in harassment law from 2012-August 2018, with new chapters on, among other topics: bullying and gender violence in the workplace; harassment based on gender non-conformity/stereotyping and sexual orientation, multiple-status or intersectionality, and association or third party status; bystander issues; federal investigation and enforcement efforts under Title IX; and arbitration and mediation of harassment claims.

An on-line update of the treatise (currently available in hard copy and on-line) is slated to be published in 2020, covering the period from the nomination of Justice Kavanaugh through 2019, with additional new chapters on human trafficking and on preemption of common-law claims.

• 6th Circuit: At the first Fellows lunch held in Columbus, Ohio on October 10, 2019, in conjunction with the Ohio State Bar Federal Bench and Bar Conference, 6th Sixth Circuit Regional Activities Committee members Charles Warner and Diane Soubly welcomed the group to a delicious lunch and explained the emphasis on regional activities in the College's amended Strategic Plan, with the Committee's next goal to plan a joint Sixth and Seventh Circuit conference with the Seventh Circuit Regional Activities Committee. Fellow and Assistant Attorney General, US Department of Justice, Civil Rights Division Eric Dreiband (pictured above with Fellows) travelled from Washington DC to speak to the assembled Fellows about the Division's initiatives. Those initiatives include prosecuting perpetrators of violent hate crimes such as the deadly car attacks by an avowed neo-Nazi against anti-white supremacist protestors in Charlottesville and the mass shooting at the

Tree of Life Synagogue in Pittsburgh, pursuing hundreds of prosecutions for human trafficking with the help of international partners (especially Mexico), and ramping up efforts to combat sexual assault. The initiatives also include pursuing employer document abuse in violation of federal law by requiring more documents than US citizens are required to produce before hiring, seeking resolutions and settlements on behalf of disabled individuals kept in "sheltered workshops" that do not pass the *Olmstead* 3-part balancing test, and pursuing employers who refuse to hire American workers in favor of foreign workers present in the US on H2A visas (whom they provide lesser pay and benefits) without demonstrating that there are not enough American workers who can do the jobs.

 On October 15, Fellows of the College of Labor and Employment Lawyers within the 6th Circuit welcomed newly elected Fellows of the College at an elegant reception held in the beautifully renovated Detroit Room of the Theodore Levin Federal Courthouse, sponsored by the College and four law firms: *Pitt McGehee Palmer & Rivers PC* (Royal Oak, MI); *Gasiorek, Morgan, Greco, McCauley & Kotzian PC* (Farmington Hills, MI); *Butzel Long PC* (Detroit); and *Varnum LLP* (Detroit). 

#### IN MEMORIAM



The College mourns the October 13th passing of Fellow Susan Grody Ruben after a courageous battle with kidney cancer. Inducted into the College in 2011, Susan actually had an early career as a professional French horn musician. Ultimately, she became a successful labor and employment attorney before opening her own mediation and arbitration practice. She was inducted into the National Academy of Arbitrators and taught dispute resolution across the country.
